Information to users about the processing of their personal data

pursuant to and for the purposes of art. 13 of EU Regulation 2016/679

In compliance with the provisions of the EU Regulation regarding the protection of individuals with regard to the processing of personal data, information is provided to users who consult this website, in particular to those who interact with the web services accessible electronically from the address www.paolaparonetto.com, corresponding to the homepage. The information concerns the purposes and methods of processing personal data, the scope of communication and dissemination of the same, their nature, and their provision.

The information is provided only for this website and not for other websites that may be consulted by the user through links. The website indeed contains links to other websites that do not belong to or are not under the direct supervision of the manager of this website (hereinafter referred to as the "PUBLISHER"), who, consequently, is not responsible for any unlawful conduct or actions not in compliance with current legislation, also in relation to the protection of individuals with regard to the processing of personal data, adopted on said websites.

1. Data Controller

2. Purposes of processing

The processing of data is exclusively aimed at facilitating the use of web services accessible electronically from the address www.paolaparonetto.com.

All processing is based on the principles of fairness, lawfulness, and transparency, safeguarding the confidentiality and rights of the user.

3. Provision

The provision of data is necessary for the technologies used on the web.

4. Type of data processed, cookies, and social networks

Browsing data

The computer systems and software procedures used to operate this website acquire, during their normal operation, certain personal data whose transmission is implicit in the use of internet communication protocols. These are data related to telematic traffic that by their nature are not immediately associated with the user, but through processing or association with data held by third parties, could allow the user to be identified (e.g., IP address, or domain name of the computer used by the user connecting to the site, or other parameters relating to the user's operating system and computer environment, and more).

These data are used only for anonymous statistical information regarding the use of the website or to check its correct functioning. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the website: they constitute full and incontrovertible evidence of the facts and actions carried out by the user in relation to the PUBLISHER, the Data Controller, and/or Third Parties.

The data are of an absolutely confidential nature and can be exhibited and/or provided only at the request of the Subjects expressly indicated by Law. The Data Controller adopts all necessary technical and organizational measures to ensure this confidentiality. The data are kept by the Data Controller for the period strictly necessary and in any case in accordance with current legal provisions. After this period, the data are destroyed, and it is no longer guaranteed the possibility of obtaining a copy.

Data provided voluntarily by the user

There is no data provided voluntarily by the user.

Cookies

Cookies are small text files that are sent from the computer on which the website is running, stored on the user's device during navigation, and perform various functions such as remembering the selected language data, collecting statistical information about the pages visited, identifying the browser and device used, selecting content and communications tailored to the user's preferences, and more. They are then sent back to the computer on which the website is running during subsequent visits.

This website uses cookies that allow storage and transportation of information. The cookies used are provided both by the website manager (PUBLISHER) and by Third Parties (so-called THIRD PARTIES).

Cookies can be of various types, depending on the type of data they store and how long they remain stored on the user's device.

The website uses "technical" cookies of the PUBLISHER and THIRD PARTIES to ensure and facilitate navigation and use of services, namely:

- "navigation or session" cookies of the PUBLISHER that guarantee normal navigation and use of the website (allowing, for example, authentication to access a restricted area) and avoid resorting to other potentially privacy-invasive computer techniques for user navigation and do not allow the acquisition of the user's personal identifying data;
- "functionality" cookies of the PUBLISHER and THIRD PARTIES that allow the user to navigate based on a series of selected criteria (e.g., language) in order to improve the service provided to the user.

"Profiling" cookies are not used on the website, i.e., cookies aimed at creating profiles related to the user and subsequently used to send advertising messages in line with the preferences expressed by the user during web browsing.

For the installation of "technical" cookies, the prior consent of the user is not required. However, the user can always request the deactivation of cookies by changing the browser settings; however, this deactivation may slow down or prevent access to certain parts of the website.

The installation of "profiling" cookies instead requires the user's consent. The user must express their will, and if they do not make any choice and still decide to continue browsing the website, they will consent to the use of such cookies.

Social networks

The website includes so-called social buttons, which are those "buttons" that depict icons of social networks (Facebook, Instagram) and allow the user who is browsing to interact with a "click" directly with the social platforms.

The social buttons used by the website are links that refer to the Data Controller's accounts on the social networks depicted. Through the use of these buttons, "profiling" cookies of THIRD PARTIES may therefore be installed.

Similarly, the website contains links that refer the user to other websites, some also through advertising images, that do not belong to or are not under the direct supervision of the manager of the website itself, and some of them may use "profiling" cookies.

5. Processing methods

Data processing is mainly carried out using computer and telematic tools, with logics strictly related to the purposes and in such a way as to ensure the security and confidentiality of the data, by subjects who are specifically appointed as Data Processors and/or Data Controllers by the Data Controller.

6. Storage

The user's personal data are stored only for the time consistent with current legal obligations.

All information collected is stored and kept in secure structures that limit access exclusively to authorized personnel. Services are constantly maintained to check for any security breaches and ensure that all collected information is protected from unauthorized intrusions by third parties who may seek to take possession without authorization.

The Data Controller adheres to all security measures described by the

laws and regulations applicable and in force in the European Union and adopts all appropriate measures according to the most advanced criteria currently available to ensure and guarantee the confidentiality of users' personal data and minimize, as much as possible, the dangers posed by unauthorized access, removal, loss, or damage to users' personal data.

7. Communication and dissemination

Subject to communications made in compliance with legal and contractual obligations, for the defense of rights and upon request by the competent Authorities, the data may be communicated to:

- employees and/or collaborators of the Data Controller to whom the transfer of data is necessary or is aimed at carrying out the activity requested by the user;
- Professionals and/or Studios and/or Companies for administration and management that may operate on behalf of the Data Controller;
- Professionals and/or Studios and/or Companies for the installation, maintenance, updating, and, in general, the management of hardware and software owned by the Data Controller or used by it for the provision of its web services.

The recipients of the communication are in any case specially appointed as Data Processors and/or Data Controllers by the Data Controller.

The user's data is not subject to any dissemination (i.e., communication to an unspecified number of other subjects).

8. User rights

The User can exercise a series of rights.

First of all, they have the possibility to obtain from the Data Controller information about the origin and purposes of the processing of their personal data, the categories of data being processed, to which recipients or categories of recipients their data have been or will be communicated, the storage period, or, if this is not possible, the criteria used to determine it.

Regarding the personal data provided, the User has the right to obtain the correction of incorrect data and the integration of incomplete data. They have the right to deletion of the same, to the extent not attributable to legal and contractual obligations, and to the restriction of processing in certain circumstances. It is also their right to receive from the Data Controller their personal data and to transmit them to another controller without any hindrance.

They have the right to withdraw their consent at any time for each purpose to which they have given consent.

They have the right to lodge a complaint with the supervisory authority.

9. Changes

The Data Controller reserves the right to periodically update this information without notice, guaranteeing in any case adequate and analogous protection of personal data. In this case, any changes will take effect immediately upon publication on the website.

In order to view any changes, the user is invited to regularly consult this information, which in any case indicates the date of the last modification.

10. Consent

The expression of consent to the processing of personal data by the Data Controller, as indicated and qualified above, since it is exclusively related to specific browsing needs, is not necessary pursuant to art. 6 par. 1 lett. b) of EU Regulation 2016/679.
